Give us the ability to adapt to the cultural, economic and social changes that occur in the neighborhoods we serve.



MINUTES OF SPECIAL CONGREGATIONAL MEETING SUNDAY, DECEMBER 10, 2023

Meeting called to order by Council President

John Korzilius, chairman of the board at Zion Mutual Homes presented the motion to authorize the replacement of the elevator at Zion Mutual Homes. Motion seconded The present elevator is now nearly 40 years old (was expected to last 25 years). John pointed out that repairs to the present elevator could result in its being out of operation for as long as six months, contingent upon getting replacement parts. Installation of a new elevator would mean only about two weeks of downtime.

Motion carried on voice vote.

John made the second motion to approve accepting the bid of \$87,000. proposed by TK elevator. They can utilize part of the present elevator which kept cost down. Arne Carlson, site manager, had gotten bids and TK was the lowest. Financial arrangement to pay for the elevator will be handled through Zion Mutual Homes and will not impact the budget of Zion Lutheran Church.

Motion carried on voice vote.

Motion made, seconded and approved by voice vote of adjourn.

ANNUAL REPORT FROM COUNCIL PRESIDENT

Oh, what a year 2023 was for Zion. We saw our congregation revitalized by the pastoral leadership of interim Pastor Jake Czarnik-Neimeyer with the support of Pastor Mike Dismer. Their wonderful unselfish ministry brought laughter, joy and most importantly, the rekindling of hope for our future. The interim time with us is over but the message they left is: "With God all things are possible". Our thanks for their ministry is to move forward in faith into the future God has planned for Zion.

To sustain the day to day operation of our beautiful facility requires many hands. Our office coordinator, Sarah Clarke, left in November but Kimberly Gordon has stepped in the position, making a seamless transition to keeping the office running smoothly. She is assisted in seeing that bulletins, the Messenger, and other office tasks are completed by a group of dedicated volunteers, Lynn Walter, Janice Staedt, Linda Wirtz, Sue Joosten and others, as well as the money counters who tally our weekly offerings, namely Gwen Schwandt and Diana Staedt.

Our maintenance engineer, Elliot Pegel deserves our thanks for keeping our facility running smoothly with the support of our Property Committee, Gary Neumann, Gene Wiese, Gwen Schwandt and Tammy Mossholder. Gary and Gene have often patched and coaxed our aging machinery back to life at great savings. Our lawn in summer and sidewalks and parking lots in winter are kept looking good thanks to the hours of work by Ben Baeten and his son, Nash.

Kandie Wilz has volunteered her time and knowledge to become Zion's Parish Nurse, a position that has been vacant for a number of years. She is a valuable resource for Zion's members.

With no called pastor presently on board, the Council endorsed the hiring of a Church Administrator to keep all of the varied pieces of our church operation in place. Welcome to Karen Farlow, beginning in 2024.

The future of any congregation lies with it's youth. Thanks to Pennie Reis and Jodi Hoesli for stepping forward to revamp our education program into Faith Formation for Sunday School and Confirmation. At the heart of this change is engaging the parents in their childrens' Christian education. We also appreciate both Pastor Mike and Karen for holding Bible and book studies.

Each week our worship is enhanced by beautiful music. Music Coordinator, Heather Watney plans the hymns and special music for each week as well as playing piano. She is helped in making this happen by our volunteer choir director, Cheryl Meyer, and the bell choir director, Paula Staedt. Jim Schley lends his talent by serving frequently as organist while William Surtees (a Lawrence student) brings his talent to us as well. Someone once told me that even the greatest sermon reaches the heart and mind but music touches the soul. Zion has benefited from the great talent of all our musicians.

We often joke that where there are Lutherans, there is food. That is certainly true here at Zion. Our fellowship hall is filled after worship with wonderful treats. Colleen

Malchow, Elmer & Karen Luedtke, Gail Hunter, Tom & Sue Joosten, Diana Staedt and others consistently make this happen and provide these delicious goodies each week. Additionally there were numerous other food-related activities, providing the noon meal to the Habitat for Humanity builders at various Appleton locations. We flipped burgers and brats at Porch Fest held this summer in our historic neighborhood. Lent meant soup suppers for our members which was carried into Advent soup suppers where our neighbors were invited and who responded enthusiastically.

The highlight of the year, of course, was the celebration of Zion's 140th anniversary, It was an overwhelming success, bringing back former pastors, former and distanced members and friends to reconnect and reminisce. Now while we can cherish that heritage, we must realize that to maintain a viable faith community we must look to the future.

Knowing the the Appleton Bilingual School which rents a large portion of our facility will be leaving as of August 31, 2025, we brought Dr. Bonnie Nussbaum on board to help chart our course into the future uses of our large campus while also generating much needed revenue. She has brought in GLCI (Generative Local Community Institute) to assist with the Boldt Company in doing feasibility studies of the potential we have. Discussions have been held here at Zion, with neighborhood residents and community leaders dedicated to making this Affordable Housing initiative. Exciting possibilities.

Unfortunately this also raises the financial situation. Grace VanEyck has been our dedicated Financial Coordinator for more than 10 years and is looking forward to a well-deserved retirement. To that end we have contracted with Lambert Business Solutions to handle our bookkeeping and business matters. This change will actually provide a cost saving. Jon Meyer and the Stewardship Committee and the Finance Committee will continue to work toward raising awareness of the needs for continued regular and generous contributions, while maintaining prudent financial practices.

This report is longer than I had planned, but I felt it necessary to keep open communication and transparency of what Zion is and what it can be. Our church building has the beauty of a cathedral but the church is not a building, it is people, a faith-filled community who spread God's love into the world around them. Remember, "I am the church, you are the church, all who follow Jesus, we are the church together!"

- Establishment of the Affordable Housing Project with Dr. Bonnie Nussbaum as the project manager

I want to thank Pastor Mike Dismer who has been a very supportive member of the pastoral team and dedicated leader in the Zion community. I also want to thank the staff who have remained diligent in their duties to maintain a functional ministry on a consistent basis. Special thanks to Sue Bunkert, council chair, and the entire church council for their faithful leadership and support through all the transition of the past year. There are too many other dedicated members to thank but, it has been a real team effort to bring new life into the Zion community.

Please keep the Call Committee and staff in your prayers as they work through this time of transition. As the year ends, we welcome Karen Farlow to serve as the new church administrator who will provide consistent leadership as Zion re-imagines how it functions as a faith community.

It has been a privilege and an honor to be your servant leader over the past 14 months. May God continue to bless the good people of Zion as you live out your mission: "Creating Community through God's Love and Guidance".

Worship and Music Report

The Worship and Music Committee participated in many events this year, along with helping to plan weekly and holiday services.

We started the year with an Epiphany Walk including a catered Brunch after. Thank you to St. Mark's, Neenah for their gift from their endowment.

Ash Wednesday brought a snowstorm and the cancelation of services that night. We had ashes available to those that wanted at the Sunday service.

Our Lent Soup Suppers and services were well attended. Maundy Thursday service included foot washing by Pastor Jake. Good Friday service was an Ecumenical Service held at First English.

Palm Sunday service was led by the children processing into church and followed with a Brunch.

Easter Sunday was a wonderful service with guest musicians to praise the risen Christ.

We had a Christmas in July service and enjoyed singing our favorite Christmas Carols. In August we celebrated with a picnic at Linwood Place, inviting the residents to join us. We were entertained by a Blue Grass Band during the service and enjoyed a pot luck meal after. Bingo was enjoyed by all.

As you can see we had an exciting year at Zion, with many more to come. A special thank you to Pastor Jake and Pastor Mike for the guidance they gave not only our committee, but our Congregation.

Music Ministry

The Music Ministry consists of: Heather Watney (music coordinator), Cheryl Meyer (volunteer choir director), Jim Schley (volunteer organist), and Paula Staedt (volunteer bell choir director). As 2023 progressed a variety of musicians were brought on board to serve the community of Zion. This variety of musicians brought an enjoyable diversity of styles and personalities to worship at Zion.

- In January of 2023 the music ministry had the assistance of Colleen Perrine (Prince of Peace Lutheran) and Sondra Joten (Prince of Peace Lutheran) to pick hymns and play for worship.
- In early February 2023 Heather Watney, Music Coordinator, joined staff to work part-time helping program hymns, report copyrights, work with other Zion musicians, and play for Sunday Worship.
- In late February 2023, Pam Keane (St. Bernards Catholic Parish) played for Wednesday evening Lenten services as we meditated on Christ's journey to the cross by singing Holden Evening Prayer by Marty Haugen.
- In March 2023 Lawrence organ student William Surtees joined the roster of organists at Zion, and currently plays for worship periodically as well as accompanies the choir.
- Guest organists John Schwandt (Concert Organist from Ohio) and Dan Schwandt (Lawrence University) played periodically through 2023 for worship. They shared their talents for the Anniversary Celebration, Father's Day, and New Years Eve day worship services.

Zion Choir:

The 14-person choir under the direction of Cheryl Meyer meet once a week on Sunday morning 8:00-8:40am to rehearse. They share their music several times a month, utilizing psalms, hymns and a variety of special music to perform during worship. Several choir members are also instrumentalists and blend those melodies in with hymns to create interesting variations, or share as solos. Tower Ringerz Bell Choir:

In 2023 we were fortunate to see bells return to worship services in the fall! Anniversary Celebration, October 15th

To celebrate the history of Zion, traditional hymns, many that would have been familiar at the founding of Zion, were played on the organ by John and Dan Schwandt, accompanied by brass musicians from the Lawrence University and the area. Virtuosic preludes, offertory and postludes were a treat to hear. The choir also sang special anthems and liturgical pieces.

Sunday School Pageant, December 17th

In the week before Christmas, Zion was treated to watching its littlest church goers sing and act out the Christmas story under the direction of Pennie Reis. It's always special to hear children talk and sing about Jesus (and wisemen, and shepherds, and the virgin Mary), and we look forward to the next time the Sunday School children can share their voices in song.

Christmas Eve

For the 4:00pm Christmas Eve service, a quartet of Fox Valley Symphony string players performed with hymns, under the direction of Heather Watney. Special accompaniment music for the strings was composed by Heather Watney. Paula Staedt helped play chimes for the sending hymn. There are currently nineteen members of Zion that are either homebound in their own home or confined to an Assisted Living or Nursing Home facility. The visitation ministry of Zion extends to those who cannot be a part of our worship services. The church comes to them with Holy Communion, prayer and sharing faith stories every 6 to 8 weeks. The volunteers involved with this ministry are: Ellen Gast, Marilyn Hetzler, Sue Joosten, Tom Meltz, Jo Schiedermayer, Gwen Schwandt and Janice Weber.

Zion Mutual Homes Annual Report

2023 was a year of change at Zion Place. Thank you to all the Zion members who voted to upgrade the elevator.

The last three Zion member residents left. The resident management team, Arnie and Barb Carlson, joined Zion in June.

For the first 25 plus years, ZMH operated under a "life lease" program. It was a financial disaster. 10 years ago, Zion place was over \$750,000 in debt. The ZMH Committee voted to change to a rental program for new tenants. Over the years, the debt has decreased. As of 12-31-23 there is a \$10,000 surplus.

The ZMH Committee voted to increase the rents by \$25.00 per month as of 1/1/2024. This is the first change since the rent program started.

Replacing the laundry room floor and painting the second floor gathering space and storage garage were the major improvements.

There are 5 life lease and 23 full units with a 60 plus person waiting list.

The Property Committee is entrusted with the care of the properties of Zion. We have a large facility that needs constant care. Due to the vacancy of a janitor on the staff, we extend our thanks to many volunteers who assist with the day to day care.

Elliot Pegel, Maintenance Engineer, is a great addition to the Staff. He works 10 hours per week. Ben Baeten and his son Nash take care of lawn mowing and snow removal. Greg Pettigrew takes care of cleaning the Sanctuary. The Appleton Area School District, cares for janitorial work throughout the week on the first & second floor, fellowship hall and gym.

Some highlights of minor & major repairs for 2023 are:

- * Bids for roof replacement (\$29,419) over the garage, breeze way & flat roof of Parish House are on file and scheduled for spring completion.
- * WE Energies conducted an energy audit.
- * Concrete work on Commercial St. including both driveway entrances was completed.
- * Engineers from the Boldt Company have been on site to do feasibility studies of our campus.
- * Re-building Together of Fox Valley volunteers came in to paint the Ark (room under gym).
- * The small cupola on the roof of the Sanctuary was removed and roof enclosed. The Peregrine Falcons living in the steeple and were tagged by bird experts for State of WI.
- * August Winter (HVAC Company) representatives reviewed our heating system & future needs.
- * The refurbishing and new lighting for the exterior cross, north side of the building.
- * City of Appleton removed dead trees from the terrace on Oneida St.
- * Worked with representatives of Affordable Housing about future of Zion's buildings.
- * Maintenance of clock works, bells, vertical lifts, and electrical issues have all been done by Gary Neumann & Gene Wiese.
- * The Committee coordinates the building security for extra worship services, funerals & Sunday opening & closing.
- * The Vertical Lift at the main entrance of the church is beyond repair.
- * Crossways Camping Ministry has vacated the Parish House.

There were 31 delegates representing 15 congregations in attendance in person and via Zoom. Gail Hunter and Wendy Sachs attended in person.

Bethany business was taken care of including review of the 2022 annual meeting minutes, the president's report, the administrator's report and the financial report. The president reported the biggest concern is filling current employee openings.

Financial report excerpts:

- Bethany Home, Inc. experienced (\$677,962) loss from operations for fiscal year ending September 30, 2022 with reduction in Covid funding as the major contributor to this.
- Bethany Shadow Woods, Inc. recognized net operating revenues over expenses
 of \$122,017 for fiscal year ending September 30, 2022. This was slightly lower
 than the previous year, primarily due to turn over in the duplexes and time
 required to refurbish the units prior to new occupancy.
- Independent audit conducted by WIPFLI for financials end of September 30, 2022 and 2021 "In our opinion, the combined financial statements referred to above represent fairly, in all material respects, the financial position of Bethany Home, Inc. and Related Organization as of September 30, 2022 and 2021, and the results of its operations and its cash flows for the years then ended in accordance with account principles generally accepted in the United States of America (GAAP)."
